PRIVATE GROUP TOURS: TERMS AND CONDITIONS

Accessibility: Each Harbour Trust tour has a different level of access based on the site conditions where the tour will take place. The Group Organiser is encouraged to read the accessibility requirements for each tour to make an informed decision about whether the tour is suitable for their group.

Filming / Photography: Tour participants are welcome to take personal photos and videos around most parts of the Harbour Trust's sites. However, we kindly ask that you avoid filming during the tour. If taking photographs, please focus on the sites' points of interest only and avoid capturing fellow tour participants, to help respect everyone's personal privacy.

Safety: All tour participants must comply with the safety directives issued by Harbour Trust Volunteers, Guides, Rangers and Security staff.

Tour participant behaviour: To ensure the safety of participants and Harbour Trust staff, at the discretion of the Harbour Trust, any participant(s) who appears intoxicated, disruptive or displays consistently unsafe behaviour, will not be permitted to take part in the tour, and / or may be asked to leave the tour at any time. Refunds will not be provided.

What to Bring: Each tour information page includes a recommended list of items to bring, based on the tour duration and site conditions. Whilst these recommendations are a guide only, tour participants are solely responsible for bringing and wearing appropriate footwear, clothing, and other necessities, such as but not limited to sunscreen, water and a torch (where indicated). The Harbour Trust accepts no responsibility for any injury or loss arising from a tour participant's failure to follow these recommendations.

Cancellation / Rescheduling: The Harbour Trust reserves the right to cancel, reschedule or alter tour dates and routes at its discretion. In instances where tours are cancelled or rescheduled, the Harbour Trust will endeavour to contact the Group Organiser, within a reasonable amount of time prior to the pre-booked tour date and time. If the tour is cancelled by the Harbour Trust at its discretion, the Group Organiser may contact the Harbour Trust to reschedule their tour for another date and time.

Booking changes: It is the tour group's responsibility to attend and arrive on time for a tour as advised in the Harbour Trust's Tour Confirmation correspondence. Changes to the group booking, including but not limited to the tour date, start time and cancellations, are required to be made to the Harbour Trust in writing 7 business days prior to the agreed tour date. Cancellations made by the Group Organiser within 7 business days of the agreed tour date will be charged a cancellation fee for the cost of the Guides rostered for the tour.

No-Show charge: It is the tour group's responsibility to attend and arrive on time for a tour as advised in the Harbour Trust's Tour Confirmation correspondence. Groups who do not arrive for their tour as



advised in the Harbour Trust's Tour Confirmation correspondence without prior notice in writing will be charged a 'No-Show' fee for the cost of the Guides rostered for the tour.

Weather conditions: Tours will proceed regardless of weather conditions except in the event of dangerous weather. If your tour is cancelled due to dangerous weather, as determined by the Harbour Trust at its discretion, we will make every effort to contact the Group Organiser as soon as reasonably practicable. In this case, the tour may be rescheduled for another date and time or cancelled without charge.
